- Lead data cleanse activities. Define cleanse projects and methodologies to be used. Manage any additional resources used during the project (internal and external)
- To be the data lead and project team member for technical change including major projects; ensuring best practice, standards and alignment to other systems are followed
- To be the owner of the data change pipeline of business requirements
